Charitable Incorporated Organisation (CIO)

Rationale for CIO status

- CIO is an incorporated structure which will give Charity a legal personality.
 It can hold property in it's own name and enter into agreements with third parties.
- The liability of members is limited to the sum guaranteed. Current member liability is unlimited.
- A more efficient, single tiered, governance structure ensuring clear accountability.
- It is an efficient and recognised structure. Authorities and corporate donors prefer to deal with incorporated structures.
- The 2006 KMA Constitution is outdated, contains inconsistencies resulting in confusion without delivering the above benefits.



Status and next steps

- Membership approved draft constitution for CIO and authorised Trustees to register it – KMA AGM 1 November 2015.
- CIO registered by Charity Commission 14 February 2020.
- EGM for CIO asset transfer resolution was scheduled in March 2020 but postponed to COVID
- Seeking members approval at a general meeting to transfer the assets to CIO 30 October 2022.

Note - KMA's 2006 constitution continues to relate to existing unincorporated charity.



Resolution on 30 October 2022

The resolution you will be asked as members to approve on 30 October 2022:

It is in the best interests of the unincorporated charity to transfer the assets and undertaking of the unincorporated charity to the CIO.
